This site is one of the most important local sites in the Tendring district and its current condition fulfils all the criteria justifying its designation. In addition, Walton Mere provides supporting habitat for the adjacent Hamford Water SSSI/SPA/Ramsar. European case law (the Portsmouth Stadium case) has established that supporting habitat required by the interest features of an SPA receives the same level of protection as the SPA habitat itself.
